INSTRUCTIONS REINSTATEMENT OF ARKANSAS PLUMBER LICENSE

Complete the application in detail, reinstatement fees are to accompany the application.

Reinstatement of Expired License.

To be considered for reinstatement you must complete all portions of the application. Only Journeyman and Apprentice level applicants need to fill out the last section respective to their license level. The applicant shall pay the applicable reinstatement fees. Licenses that expired due to non-payment of renewal fees, may be subject to additional back fees and penalties. **The Department will determine if an examination is required.** Master Plumbers with Apprentices, whose licenses expired for nonpayment, may be subject to civil action.

- Master Plumber reinstatement fees with no penalties: Three hundred and twenty-five dollars. (\$325)
- > Journeyman Plumber reinstatement fees with no penalties: One hundred and fifty dollars (\$150)
- Apprentice Plumber reinstatement fees with no penalties: Twenty-five dollars (\$25)
- ➤ Back fees and Penalties: The annual license fee plus five dollars (\$5) per month for each year and month lapsed.

After a license has been delinquent for non-payment of fees for over a period five (5) consecutive years, the application for reinstatement shall be determined by the Committee of Plumbing Examiners with or without examination.

Reinstatement of Deferred License.

A Master or Journeyman Plumber whose license has been officially deferred may apply for reinstatement. The Department may reinstate such license without examination upon payment of the current license fee and a reinstatement fee of twenty dollars (\$20.00).

After a license has been deferred over a period of five consecutive years, the application for reinstatement shall be determined by the Committee of Plumbing Examiners with or without examination.

Reinstatement of Revoked License.

A Master or Journeyman Plumber whose license has been revoked may make application for a new license one year after the date of revocation. A statement of intent to comply with all pertinent laws and regulations shall be attached to this application. The Committee of Plumbing Examiners may issue a new license after the applicant has passed the prescribed examination. Fees for such license shall be the same as for a new license.
