Pre-Licensure Petition Approval Chuck Thompson  
No petition approvals today

In the future, pre-licensure petition approvals, if the petitioner is not incarcerated, will be brought to CTAC.

If the petitioner is incarcerated, pre-licensure approval will be decided before release, brought before CTAC before petitioner leaves ADC. This process is more efficient.

Program Update

Thompson - CTAC probably will have more administrative hearings regarding injecting. There has been contact with federal agency regarding acting outside the scope of cosmetology practice.

Question by Strawn about medical licenses in salons.  
Answer by Thompson - if there is a medical director of any sort, CTAC does not go in, issues go to medical board. In that case, CTAC has no authority. If there is a medical director, salon is not using their cosmetology license.

If injection procedures are taking place and there is no medical director, CTAC needs to know.

What about APRN - Thompson will investigate with the medical board. APRN may not need a collaborative agreement.

The overlap of authority can be a gray area. If there is any question, report it to CTAC. Additional discussion regarding teeth whitening.

If there is a person violating rules, can the salon also be held responsible, in addition to the person? The salon should be given notice to cease practice.

Strawn - question on Act 990 - If there are untruths on an application, can a prospective student be required to present a background check?

Probably the school does not have access to ACIC/NCIC. If any information is public, school can use it.

Burton - question on Act 990- Can a school require a background check? The school needs to consult with its own attorney.

Thompson - Act 990 is part of red tape reduction plan. But the act could potentially cause more red tape and some administrative burdens. Act 990 does not give background check authority for licensing.

If there is information discovered on the back end, it could be considered fraud and CTAC could then revoke license.

In the past (pre-Act 990) there was only one prohibiting offense, committing a crime while performing cosmetology services. Act 990 changed this.

CTAC members can personally bring issues to their elected representatives.

Kelli - the rules are out for public comment. Public

comment hearing is August 1 in person at 9:00 a.m. Rules will probably have to come back to the committee.
