### **Budget Guidelines**

Grant funds may not be used for equipment, rental space, out-of-state travel, food, or gift cards. Grant funds may be used for items such as salaries, office and medical supplies, and in-state registration/travel for BreastCare related conference and/or meetings.

A budget that lists the total grant amount requested through the application year and breaks out how support to the program will be utilized must be provided. A sample spreadsheet has been provided as well as budget form. The budget form is divided into two separate columns of Grant Funds.

**NOTE:** The table below is provided as a sample spreadsheet.
